Message from the Chair

reetings from Heady Hall! As I reflect on the events of the academic year that is coming to a close, I am reminded of how complicated and multi-faceted an institution a Public Land Grant University like Iowa State University is. There are, of course, our undergraduate and graduate education missions. Providing an excellent education for the next generation is certainly central to ISU's identity, but this educational mission is only a fraction of the activity that takes place on campus.

In particular, the faculty and staff of the university are a remarkable and dynamic source of expertise that serves the state of Iowa, the nation, and the world. In the past year, for example, a large group of faculty, which included two economics faculty, Professors John Crespi and Alejandro Plastina, participated in drafting a 280-page report on emerging opportunities in Iowa for carbon markets. The report was a response to an executive order issued by Governor Kim Reynolds on June 22, 2021 calling for a task force to review "...the research on carbon sequestration, considering any gaps in current assessments, and determining whether new research, standards, or definitions should be developed." As the report highlights, despite considerable unknowns, Iowa is well situated to lead the nation in carbon management.

Faculty are crucial to the university's ability to absorb cutting edge knowledge, assess its relevance to policy questions and then communicate these conclusions. But their effectiveness also hinges on a

less visible, but no less important, group of professional and scientific staff. This spring we bid farewell to one of these staff, **David Swenson**.

Dave, whose job title was simply "research scientist," first came to Iowa State in 1989, and has over the years worked with numerous communities throughout the state to assess the potential economic impacts of community economic development plans. Through this work, he became the go-to person for reporters throughout the state seeking to understand how one or another recent development might affect the state. While the work that Dave, and other research scientists at the university, performs doesn't intersect with the university's more visible classroom teaching, it is nonetheless central to the university's ability to serve the state effectively.

Unfortunately, the financial model of the university is making it harder and harder to support activities that are not directly tied to instruction. State appropriations have been a shrinking part of the overall ISU budget for decades. Today, close to two-thirds of ISU's general fund budget comes from student tuition and fees. And with student enrollment down by close to 20 percent from its peak in 2016, both colleges with which the department is affiliated — Liberal Arts and Sciences (LAS) and Agriculture and Life Sciences (CALS) — are confronting budget deficits that are being passed along to their departments.

Over the last few years, the economics department has trimmed expenditures funded by CALS by close to 20%, and the recently announced reimagining LAS plan to close budget gaps in LAS will require the department to cut expenditures funded by the college by about 15%. Since almost all of our budget is tied up in people, this means that positions that become vacant will not be filled, and activities that do not contribute to tuition revenue will be subjected to especially close scrutiny. Public universities in Iowa are not alone in confronting these budget challenges, much the same situation is playing out in many other states as well.

Alum Panelist at Ukraine Lecture Nancy B. Brannaman (BS Ag Business/

Farm Operation, MS Ag Economics/ Finance) was one of the panelists at a virtual University Lectures event, "Personal Reflections on the War in Ukraine," March 23.

Brannaman was with the former U.S. Department of State Foreign Service in the Consular Officer in Kyiv around the time of Ukrainian independence. She and her husband John lived three years in Ukraine, two years in Russia, three years in the former Soviet countries of Azerbaijan and Uzbekistan, and two years in post-communist Albania.

"The war on Ukraine has brought suffering and death to its people. The whole world has watched as Russia attacks infrastructure, civilians, and nuclear power plants. Russia is growing increasingly isolated as financial institutions, businesses, and cultural entities cut ties with the country. The possibility of nuclear war and the effects on the world economy have shaken many. This panel will focus on the impacts the war is having on Ukrainian-Americans and those who have worked in Russia."

"We're not witnessing a war in Ukraine. We're witnessing an invasion of a peaceful, democratic, sovereign country and the citizens of that country defending themselves against tyranny. One of the most important lessons I learned from this incredible event is one must develop

Richey Speaks at Economics Club Meeting

Minister Counselor for Agricultural Affairs of the U.S. Embassy, Beijing, Bobby Richey ('86 MS economics) was guest speaker at the Feb. 9 virtual Econ Club meeting.

Approximately 90 Econ Club members and department alumni logged on to hear Richey speak about his many roles within the U.S. Foreign Agricultural Service at the U.S.D.A. since 1986. Richey earned a Bachelor of Science in agricultural economics from Texas Tech University in 1984 and a Master of Science in economics from Iowa State University in 1986. He grew up on his family's cotton farm near Lubbock, Texas. He currently has the rank of Career Minister in the Foreign Service of the United States.

Richey assumed the role of Acting Deputy Chief of Mission in Beijing on October 14, 2021. Prior to arriving in China, Bobby was the Acting Associate Administrator of the Foreign Agricultural Service (FAS), which he joined in 1986, at the U.S. Department of Agriculture in Washington, D.C.

He was also the Director General of the FAS, with responsibility for managing its Foreign Service Corps of 130 officers, mentoring 30 Foreign Service trainees, and overseeing about 350 foreign nationals working in FAS's 93 offices around the world.

Richey has served at the U.S. Mission to the European Union, and in the U.S. Embassies in Mexico City, Berlin and Bangkok. When he served as Counselor for Agricultural Affairs at the U.S. Embassy in Bangkok, he covered USDA's interests not only in Thailand, but also Burma and Laos. Over his career, he has worked on a breadth of issues ranging from international food and health regulations to global food security.

See Visits Econ Club on Law Panel

Harold See ('69 PhD economics), professor of law and former Alabama Supreme Court Justice, was one of the speakers at the Feb. 23 Econ Club Zoom meeting. See joined Bret Dublinske, an attorney with Fredrikson and Byron Law, who uses economic expertise in his work on utilities and regulation, and

J. Peter Mattila, emeritus professor, who serves as an expert witness in civil trials, on a panel discussing "Economics in the Courtroom."

Harold See is Professor of Law and a member of the charter faculty of the Belmont University College of Law. He has served as the Herbert D. Warner Professor of Law at the University of Alabama and as a Justice of the Supreme Court of Alabama. Justice See received his Bachelor of Arts degree from Emporia State University, Kansas, in 1966.

He worked his way through school as a heavy equipment operator, a sheet metal worker, and a roofer.

He received his Master of Science in economics from Iowa State University and completed his PhD coursework there. He then served as Assistant Professor of Economics at Illinois State University. In 1973, Justice See earned his Juris Doctor degree from the University of Iowa College of Law, where he graduated with honors and was awarded the Order of the Coif. He practiced law with the

Chicago law firm of Sidley & Austin. He later joined the faculty at the University of Alabama School of Law, where he served for over 20 years, successively as associate professor, full professor and the Herbert D. Warner Professor of Law. In 1996, Justice See was elected to the Alabama Supreme Court. He was re-elected to that position in 2002, retiring in 2009.

In 2011, Justice See joined the charter faculty of the Belmont University College of Law. He currently teaches courses in Intellectual Property, Trademarks, Patents, Franchise Law and Law & Economics.

Justice See is a member of the American Law Institute and the American Bar Association. He is admitted to practice in both Illinois and Alabama, and has served as reporter for the Alabama Trade Secrets Acts and for a set of revisions to the Alabama Trademark Law.

Justice See has authored or edited more than 40 books, chapters, articles, and reviews, and numerous judicial opinions.

Author speaks to club on Sabermetrics

Statistician and author Bill James spoke to the Iowa State University Economics Club Wednesday, Oct. 27 in 127 Curtiss Hall. The audience of about 70 club members and others listened to James speak on Sabermetrics, the statistical analysis of baseball. James is an American baseball writer, historian and statistician whose work has been widely influential. Since 1977, James has written more than two dozen books devoted to baseball history and statistics. His approach, which

instincts from actual experiences. I also learned that in post-Soviet countries, not everything is as it seems, and one must rely on instincts to make good decisions. Americans were and are very naïve about the motives, strategies and tactics of people who are very corrupt. But we must be more discerning, especially with the leaders of countries who have proven themselves not to hold the values that the U.S., Europe and other countries hold. Not all the people of the world hold our values of freedom, democracy, freemarket economies, the rule of law, and the importance of free and fair elections."

"The invasion of Ukraine in recent weeks has caused me, and many others, to look back, to study events more closely, and to try to learn from past oversights. It is my personal opinion, that Russia can never be trusted as a peacekeeper and Russia should never be allowed to occupy territories acquired by nefarious means. Our challenge? I believe we need to develop better diplomatic, political, economic and military strategies that defend the values of freedom, independence of sovereign nations, and the growth of democracies and freemarket economies. These strategies come with a cost."

Brannaman was joined by Dr. Lesya Hassall, who graduated from one of Ukraine's oldest and most prestigious universities, Nizhyn Gogol State University; Dr. Svitlana Zbarska, who manages programs that promote research opportunities for undergraduate students across Iowa State University campus; and Dr. Vitalij Pecharsky, who was born in Lviv, Ukraine. In 1976, Pecharsky graduated from the University of Lviv in Ukraine. The lecture was sponsored by the ISU Fulbright Association, the Iowa Fulbright Association, and the Committee on Lectures (funded by Student Government).

Hayes Honored for 35 Years of Service to Iowa State

Dermot Hayes, professor, Pioneer Chair in Agribusiness, and Charles F. Curtiss Distinguished Professor in Agriculture and Life Sciences, was honored by Iowa State's 25 Year Club for his 35 years with the university. Resuming its annual in-person banquet to honor members reaching notable anniversaries, the 25 Year Club gathered on Feb. 28 at the Scheman Building to celebrate 110 Iowa State faculty and staff — a group that represents a combined 3,260 years of university service.

Club president Rob Wallace, associate professor of ecology, evolution and organismal biology, said holding the banquet is a return to tradition after last year's banquet was canceled due to pandemic precautions. Instead of the banquet, those honored last year received a voucher for a free meal at a local restaurant. "No matter their role on campus, long-serving employees are essential to Iowa State," Wallace said. "While change is constant and necessary on a university campus, the institution also is steeped in history. Faculty and staff with decades of experience help navigate that balance between old and new. making the long view clearer," he said.

Hayes gave as his notable achievement, accomplishment or milestone as "Teaching Econ 101 to the Ag Business students for more than 30 years," and his favorite memory as "The day I found out I was going to be tenured."

Orazem Wins Inspiration Award


University Professor Peter F. Orazem has been selected to receive the 2022 Faculty/ Staff Inspiration Award. He is among five individuals to be honored with the award this year.

The Alumni Association established this award in 2011 as a way for former Iowa State University students to recognize current or former faculty or staff members who had a significant influence in their lives as students at ISU. Orazem was nominated by former student Deepak Premkumar.

Orazem is a prolific academic writer, authoring and co-authoring countless publications and serving on editorial boards for multiple respected publications in the field of economics. He gives his students the tools to pursue their professional goals through research and application. Research mentorships between Orazem and students have produced economic change that has reached the state legislature and also impacted communities throughout the state of Iowa.

"Using him as a model, I strive to be a nurturing and patient mentor to those whom I manage," one nominator wrote. "I truly cannot think of a candidate more deserving for the Faculty-Staff Inspiration Award than him."

Orazem will be honored and recognized at the ISU Alumni Association Board of Director's annual meeting and reception held on May 20 at the Iowa State University Alumni Center.

Zhang Survey Finds Iowa Farmland Values Rise 29%

Wendong Zhang, associate professor, announced the findings of the annual survey he leads with the Center for Agricultural and Rural Development (CARD) at a press conference Dec. 14, 2021, at Iowa State University's Curtiss Hall.

After several years of modest gains and losses, the average value of an acre of Iowa farmland skyrocketed 29% in 2021, according to the 2021 Iowa State University Land Value Survey. The nominal value of an acre of farmland is now higher than at any point since Iowa State University began surveying values in 1941, and is 12% higher than the previous peak in 2013; although the current value in inflation-adjusted terms is still lower than that for 2012 and 2013.

The last time farmland values increased more than 25% was in 2011, when values rose 32.5%.

"Surging ethanol demand and high commodity prices were two of the significant factors driving the increase in 2011," said Zhang. "The increase this year is in part due to much stronger commodity prices thanks to higher exports, stronger than expected crop yields, and strong ad hoc COVID-19 related government payments."

CARD offers a web portal at https://www.card.iastate.edu/farmland/ that includes visualization tools, such as charts and interactive county maps, allowing users to examine land value trends over time at the county, district, and state level.

Martens Named Chief Economist Council Moderator

Output informs those in the Department of Revenue and the State of Iowa Chief Economist as she creates briefs and information for state officials.

Martens' responsibilities include managing the work process of the meeting, ensuring formal and equal treatment of the contributors, supporting the formulation of objectives common to the group, offering editorial assistance with read-ahead and meeting summaries, and collaborating on identification of topics of discussion.

Martens, the Iowa Institute of Cooperatives Endowed Economics Professor, said, "I was honored to be asked by the State of Iowa Chief Economist and the Director of the State of Iowa Department of Revenue to moderate this council. Effectively moderating a council in which experienced and highly qualified members discuss Iowa's economy and offer forward-looking commentaries is a responsibility. When I agreed to serve

in this role, I accepted the responsibility to work diligently to make the Council as productive and useful as possible. In addition, this is an opportunity to represent Iowa State University including CALS and Extension — as we continue to serve under our common Land Grant Mission."


After Three Decades at Iowa **State, Swenson Looks Forward** to Retirement

After a thirty-two-year career with Iowa State, David Swenson, research scientist, worked his final day with the economics department March 18, 2022.

As an economics department research scientist, Swenson is the author of multiple journal articles, book chapters and more than 130 applied research reports, and has received awards from Iowa State, the University of Iowa, the University Economic Development Association, the Community Policy Analysis Network and others.

Besides doing publicly sponsored economic impact research, and providing technical assistance and direct consultation for state agencies and executives, his public engagement includes dozens of presentations as keynote speaker and panelist for a wide range of conferences and summits. He is a frequent contributor to every major Iowa media outlet, as well as national media, including NBC Evening News, Detroit Public Television, The News Hour, Marketplace, Scientific American, National Public Radio, Public Radio International, Nevada Public Radio, Missouri Public Radio, St. Louis Public Radio, Harvest Public Media, New York Times, Wall Street Journal, Chicago Tribune, Reuters, Associated Press, Bloomberg Financial, and the Minneapolis Tribune.

Swenson eagerly anticipates the future, but adds, "It's been my pleasure and honor to serve the state of Iowa in this department for the past three decades."



"It's so good to surround yourself with juniors and seniors in the same major to push you. I wanted to be CALS Council President like Alex Brand, who I looked up to, so I followed in his steps. It's a really good way to develop leaders."

Away from the fraternity, Eden was CALS Week co-chair, a member of the Dean's Student Advisory Committee and a Dean's Ag Cabinet Student representative, and was involved in Alpha Zeta Honor Society, SALC Senior Class Council and the Ag Business Club, all while making the Dean's List six times.

"Through Cole's work, the community, fellow chapters, clubs on campus and students' lives have all been changed due to his passion and commitment for the betterment of others," said Cardinal Court inductee and fraternity brother Cale Pellett, ag business senior. Student government

president and friend Julia Campbell praised Eden's "commitment to enhancing his peers' experience at Iowa State, inspiring leadership potential in others, and his ability to connect with people of a multitude of backgrounds."

Eden has accepted an associate territory manager position with Corteva Agriscience after graduation in May.

"What I learned from COVID was just to be adaptable, to be innovative and to keep your expectations fluid. Everything might not go perfectly, but as long as you have some level of success, you should enjoy the small victories along the way," Eden said.

The team is not just about football. For members, it's an avenue for economic self reliance — leasing of sugarcane fields to generate income is one of their newest ventures. When they aren't practicing soccer or preparing for a tournament, they're busy working in the fields or trying their hand at other entrepreneurial activities.

An Iowa State connection

The Ag Business Club connection with this Kenyan village started back in 2016, when some alumni of the Ag Bus program and club traveled to Maliki with Ebby Luvaga, teaching professor, and donated books to the village library. When Dr. Luvaga visited Kenya in December 2021, she delivered the club T-shirts to the Rising Star team.

Ag Bus Students Win Pork Industry Scholarships


