Since 1996 I have served as the senior mentor to two groups of junior women economists under two programs sponsored by the American Economic Association's Committee on the Status of Women in the Economics Profession and funded by the National Science Foundation. I was assisted by junior mentor Catherine Eckel with the first group of 5 mentees, all of whom are tenured, and all but one is a full professor. Yan Chen and Rachel Croson served as junior mentors to the second group. All have tenure, all but one is a full professor, and one won the 2013 Fischer Black Prize. This is the best record of any of the mentoring groups funded through these programs. In part because of this service, I won the American Economic Association's 2010 Carolyn Shaw Bell Award for improving the status of women in the economics profession.
